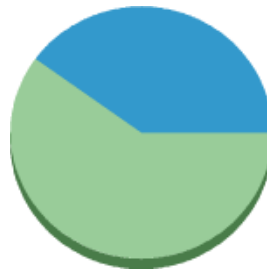

Program Description: The Blue Bar Prime Ag program seeks to achieve capital appreciation through the execution of outright long/short and spread strategies identified by technical and fundamental analysis augmented by risk management principles employed by the Advisor. The trade execution methodology used for the program is based on a process that is approximately 60% systematic and 40% discretionary.

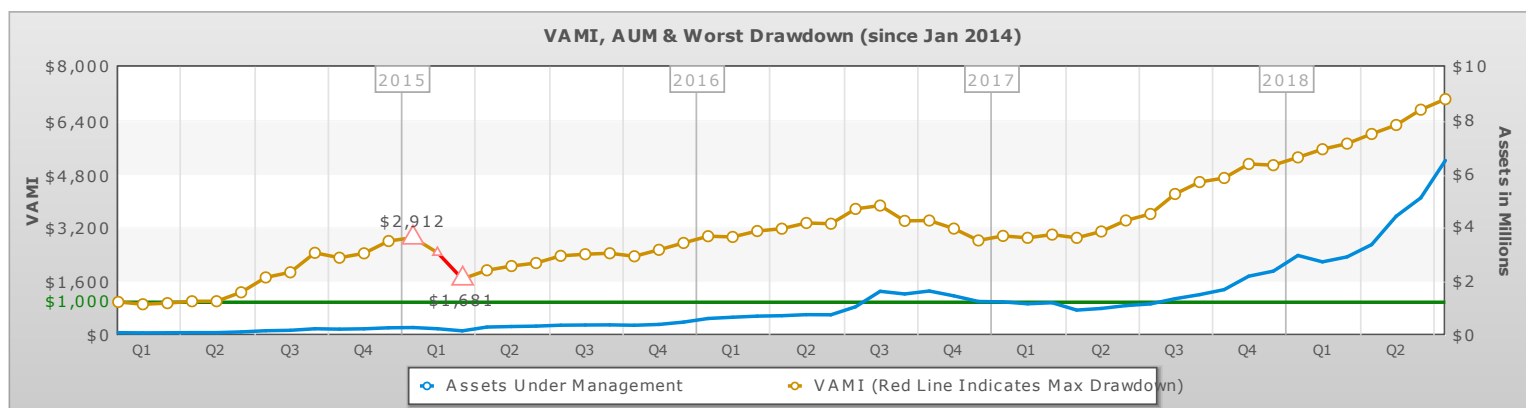
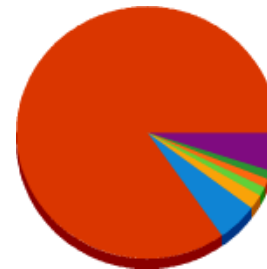

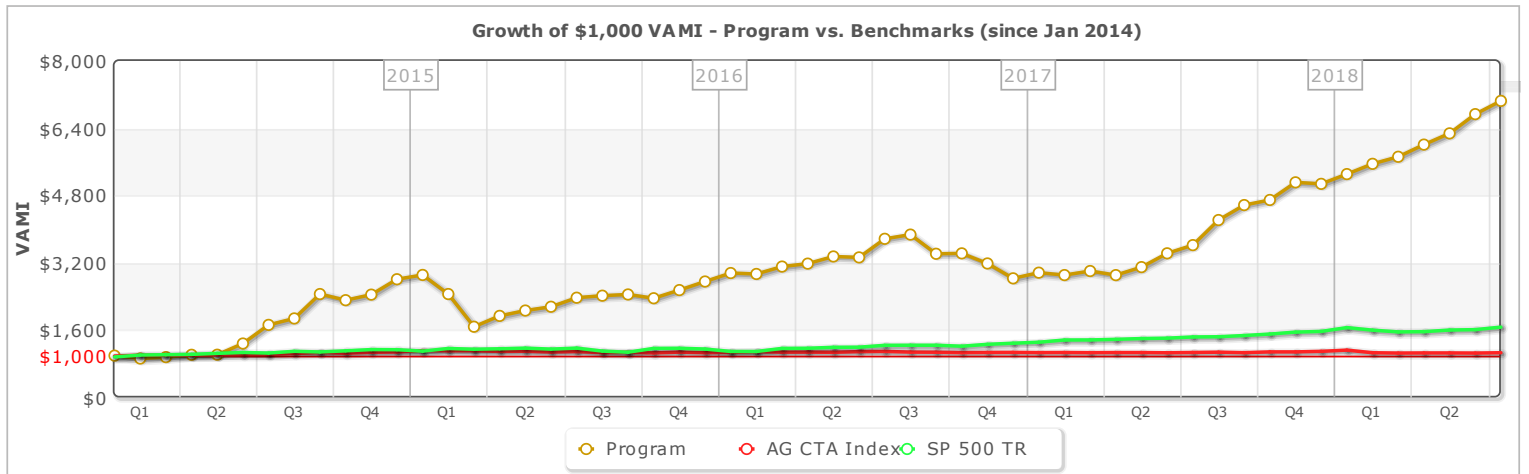
